ALCS offers four Tuition Payment Option plans. Tuition can be paid **annually** (1.5% discount), by **semester** (1% discount) or by **10 or 12-month plans**. **Annual and first semester payments are due by August 6, 2010.** Monthly payments are due by the 10th of each month. **NOTE:** A late fee of \$20 will be applied to monthly payments not received in the ALCS Business Office by the 10th of the month and to semester or annual payments not received by the 18th of the month. Payments rejected by the bank for any reason will be charged a \$25 fee.

You may choose to make payments with cash, check, or the Direct Tuition Payment Program. If you choose the Direct Tuition Payment Program, the annual and first semester payments will be deducted from your account on August 6, 2010, and second semester payments on January 7, 2011. Monthly payments will be automatically deducted from your account on the 8th of each month. If the 8th falls on a weekend or holiday, automatic deductions will happen on the following Monday or business day. Please indicate your Tuition Payment Option preference below. If you are currently using the Direct Payment Program, please resubmit the Authorization Agreement Form for the 2010-2011 school year.
